## **Definition Of Laws**



Basic Conditions of Employment Act No. 75 of 1997.	Prescribes the right to fair labour practices and minimum conditions of employment.
Compensation for Occupational Injuries and Diseases Act No. 130 of 1993.	Provides for compensation caused by occupational injuries or diseases, sustained or contracted by employees in the course of their employment, and for death resulting from such injuries or diseases.
Labour Relations Act No. 66 of 1995.	The purpose of the Labour Relations Act is not only to protect everyone in the workplace but to also promote economic development, fair labour practices, peace, democracy and social development.
Mine Health and Safety Act No. 29 of 1996.	Entrenches the right to refuse to work in dangerous work conditions; and to give effect to the public international law obligations of the Republic relating to mine health and safety.
National Health Act No. 61 of 2003.	Provides a framework for a structured uniform health system within the Republic, considering the obligations imposed by the Constitution and the laws on the national, provincial and local governments with regard to health services.
Occupational Diseases in Mines and Works Act 78 of 1973.	Consolidates and amends the law relating to the payment or compensation in respect or certain diseases contracted by persons employed in mines and works. The Act provides compensation for occupational lung diseases in miners and ex-miners only.
Occupational Health and Safety Act No. 85 of 1993.	Provides for the requirements that employers must comply with, in order to create a safe working environment for employees in the workplace.
Pension Funds Act No. 24 of 1956.	Provides for the registration, incorporation, regulation and dissolution of pension funds and for matters incidental thereto.
Protection of Personal Information Act No. 4 of 2013.	It sets some conditions for responsible parties to lawfully process the personal information of data subjects.

# What is an Occupational Lung Disease?

An Occupational Lung Disease (OLD) is a medical condition that affects the lungs and respiratory system. It is caused by exposure to harmful substances in the workplace. These harmful substances can include dusts, fumes, gases, vapour, or fibres that are inhaled over time, leading to inflammation, scarring, or other damage to the lungs.

#### WHAT ARE OLD SYMPTOMS?

Symptoms may vary from one person to the next. However, some common symptoms include:

# National Department of Health

### National Department of Health – Medical Bureau for Occupational Diseases and Compensation Commissioner for Occupational Diseases

The Occupational Diseases in Mines and Works Act 78 of 1973 (ODMWA) makes provision for the autopsy examination of the cardio-respiratory organs of deceased persons who are or were employed at controlled mines or works, regardless of the clinical cause of death.

#### MEDICAL BUREAU FOR OCCUPATIONAL DISEASES

The Medical Bureau for Occupational Diseases (MBOD) oversees the provision of Benefit Medical Examinations (BME) and certification of claims.

#### COMPENSATION COMMISSIONER FOR OCCUPATIONAL DISEASES

The Compensation Commissioner for Occupational Diseases (CCOD) compensates workers and ex-mineworkers for occupational diseases of the cardio-respiratory organs and reimbursement for loss of income incurred for temporary disability relating to occupational Tuberculosis (TB).



#### **DID YOU KNOW?**

Did you know under ODMWA the medical care for an occupational lung disease post-employment is the responsibility of the employer?

### WHAT ARE THE COMMON COMPENSABLE LUNG DISEASES THAT ARE COVERED BY THE ODMWA ACT?

LUNG DISEASES	SYMPTOMS
<b>Silicosis</b> (common in people that worked in gold mining): fibrosis and scarring of the lungs caused by long-term inhalation of dust such as silica.	Chest pain, fever, cyanosis (bluish skin), coughing, difficulty breathing, fatigue, loss of appetite and weight loss, tachypnoea (rapid breathing), dyspnoea (shortness of breath)
<b>Tuberculosis (TB):</b> an infection of the lungs by a bacterium (germ) called Mycobacterium tuberculosis causing progressive wasting of the body	Persistent dry cough, tiredness & weakness of the whole body, weight loss, poor appetite, sweating at night (even in cold conditions), pains in the chest, shortness of breath, coughing up blood.
<b>Coal workers Pneumoconiosis (CWP)</b> (common in people who worked in coal mining): fibrosis and scarring of the lungs caused by long-term inhalation of coal dust.	Cough, Shortness of breath, coughing up of black sputum.
<b>Chronic obstructive pulmonary disease (emphysema):</b> (emphysema): a lung disease caused by smoking in which the air sacs (spaces) in the lung are enlarged and damaged, making it difficult to breathe.	Coughing, sometimes with phlegm, difficulty breathing, wheezing and tiredness.
<b>Asbestosis/Mesothelioma:</b> is a form of cancer that is usually associated with previous exposure to asbestos. It grows in the pleura, which surrounds the lungs.	Abdominal pain, abnormal lumps, chest pain, fatigue, fever and sweating, fluid buildup, loss of appetite, muscle weakness, swelling, unexplained weight loss.

According to the DoH, it is the right of every ex-mineworker to be medically examined every two years to exclude an OLD. The examination is free for all ex-mineworkers. All nine provinces in South Africa have hospitals performing Benefit Medical Examinations (BME). There are selected hospitals in the provinces that provide BMEs.



#### WHAT TO DO WHEN YOU HAVE SYMPTOMS?

When you have symptoms you should get a BME that will detect any possible lung disease. Every active and ex-mineworker is entitled to this examination every two years at no cost. Listed below are places one can go to get a BME:

- A hospital or clinic at your current or former mine employer.
- The Medical Bureau for Occupational Health's office in Johannesburg.
- A public clinic or hospital near you.
- One stop centres and MBOD Service providers.

### WHICH DOCUMENTS DO YOU NEED TO TAKE WITH YOU TO GET A BME?

- A copy of your ID/passport.
- Labour history documents: from your employer or The Employment bureau of Africa (TEBA).
- All previous medical records or a clinic card.

### WHAT DO I DO AFTER GETTING A BME AND SUBMITTING ALL DOCUMENTS?

After your BME is done and you have submitted all your documents, the certification committee will look at all the documents to make a decision on whether or not you have a compensable OLD.

Once the committee has made a final decision, they will send the results back to the hospital or doctor who examined you. The doctor will then contact you to provide feedback on the outcome.

#### HOW WILL I RECEIVE COMPENSATION IF I HAVE AN OLD?

- You will be required to complete a form which can be found at the MBOD; TEBA or the One-Stop centres. You can also download it at https://www.health.gov.za/ccod-home.
- Make sure you have the correct GW24/80 form there is one for living claimants and one for beneficiaries where the claimant has passed away. The form includes the document checklist for all documents required.

## National Institute for Occupational Health

### National Institute for Occupational Health

The Occupational Diseases and Mine Works Act of 1973 (ODMWA) makes provision for the autopsy examination of the cardio-respiratory organs of deceased persons who are or were employed at controlled mines or works, regardless of the clinical cause of death.

The National Institute for Occupational Health (NIOH), MBOD and, CCOD work together to assist the families of mineworkers who have passed away while in service and after they have left the industry.

The Pathology Division of the NIOH undertakes these examinations on behalf of the MBOD and these findings are considered by the CCOD.

The Medical Practitioner who last attended a deceased miner, ex-miner or, worker from a controlled mine should arrange for the removal of the cardiorespiratory organs and send them to the NIOH for examination, provided that the deceased (during life) or the family of the deceased has signed consent thereof.

#### WHO QUALIFIES FOR A POST-MORTEM EXAMINATION?

Mineworkers who have been exposed to dust environments while working, have the right to have their lungs and heart examined after death - no matter the cause of death.

#### **HOW TO REQUEST A POST-MORTEM EXAMINATION?**

The cardiorespiratory organs (heart and lungs) of the deceased can only be removed if the deceased or the deceased's family grants permission for the examination of the organs by signing a consent form. *Please see the Annexure for a copy of the consent form.* 

#### HOW WILL THE ORGANS BE REMOVED AND EXAMINED:

The family of the deceased needs to request the last doctor who attended the patient to assist with making the necessary arrangements to remove the heart and lungs in terms of ODMWA. Removal of the organs can be carried out by either a trained medical doctor, a prosector, or an undertaker trained in organ removal, under the supervision of a doctor. The heart and lungs will then be placed in a plastic bag containing formalin for preservation. The organ(s) will then be transported, together with all the required documents, to the NIOH in Johannesburg for the autopsy examination.For miners and ex-mineworkers who die in and around Johannesburg, an autopsy can be performed at the NIOH.

#### THE POST-MORTEM PROCESS:

The following documents must be sent with the lungs:

- Completed consent form;
- A copy of the deceased's ID;
- The deceased's Record of Service, which can be any of the below (you only need to submit one of the options):
  - A TEBA record of service, stamped and signed by the TEBA official from the local TEBA office; or

- Certificate of Service stamped and signed by the employer; or
- Official documents from the employer with the details of employment the period, start and end date and any positions occupied at that time.
- Any medical records a clinic card, any x-rays you ever had done, or any letters from the hospital if you were ever sick or injured. The lungs should still be removed and examined even if the deceased was already certified by the MBOD, as a more advanced stage of disease may be evident at autopsy.

#### WHAT WILL HAPPEN NEXT?

When the lungs and documents arrive in Johannesburg, the lungs will be examined by the doctors to see if there are signs of OLD.

The doctors will then write a report for the MBOD certification committee.



The committee will then look at the report and all the other documents and decide if the deceased had an Occupational Lung Disease (OLD) and if he/she would then qualify for compensation.



If he/she qualified, they will issue a certificate and send it to the MBOD/ CCOD for processing, and they will also inform the family of the results. If the deceased qualifies for compensation, the family will need to send the deceased's information to MBOD so they can process the compensation.

### DO I NEED TO PAY FOR ANY STEP OF THE POST-MORTEM PROCESS?

No. The MBOD receives money from the Department of Health (DoH) to pay for the removal and examination of the cardiorespiratory organs.

#### WHO WE ARE?

The Employment Bureau of Africa (TEBA) has the largest mineworker database. Since its inception in 1902, it has formerly recorded the details of every mine worker that has ever been recruited in South Africa. As a result, it has developed what is regarded today as the most extensive database of miners and ex-mineworkers in the SADC region. TEBA works with various stakeholders to effect positive impact by delivering services relating to health, community development, tracing unpaid benefits and, recruitment-related services.

#### HOW CAN WE HELP YOU AS AN EX-MINEWORKER?

TEBA has branches in mining communities across South Africa, Mozambique, Eswatini, Botswana and, Lesotho. Currently, TEBA provides support to the MBOD and Minerals Council to reach out to mineworkers and the families of deceased mineworkers. Through outreach programmes, mineworkers are invited to check if they have any benefits due to them and to do a BME to check if they have any compensable occupational diseases.

#### **TEBA HEALTH SERVICES**

TEBA is committed to YOUR well-being. TEBA offers a range of healthcare services tailored to the specific needs of ex-mineworkers. These include:

- 1. TB prevention and care: We offer comprehensive services to prevent and manage TB.
  - Screening of TB contacts.
  - Document collation for referral.
  - Treatment adherence counselling and support.
  - Tracing and referral for BME.
  - Tracing of defaulters and referral for restart of treatment and continuity of care.
  - Nutrition and disease prevention education.
- 2. Home-based care: TEBA has dedicated healthcare professionals that provide essential medical support in the comfort of your home.
- 3. Home adaptations: We help to modify your home to accommodate any disabilities or mobility challenges.

# Tshiamiso Trust

## Tshiamiso Trust

The Tshiamiso Trust was constituted in 2020 to give effect to the terms of the settlement agreement reached between six mining companies (Harmony Gold, Gold Fields, African Rainbow Minerals, Anglo American South Africa, AngloGold Ashanti, and Sibanye-Stillwater) and, claimant attorneys in a historic silicosis and, TB class action.

Tshiamo Trust is responsible for ensuring that all eligible current and ex-mineworkers across Southern Africa, who suffered permanent lung impairment due to contracting silicosis or work-related TB (or their dependents where the mineworker has passed away) are compensated.





#### These statistics are as at 16 August 2024.

#### WHO CAN LODGE A CLAIM?

Mineworkers who worked at one or more of the qualifying mines during the period 12 March 1965 - 10 December 2019 and suffered permanent lung impairment due to silicosis or, work-related TB. If deceased, their dependents can also lodge a claim.

#### HOW TO CHECK IF YOU ARE ELIGIBLE TO LODGE A CLAIM?

Claimants can check their eligibility by:

- Calling the Tshiamo Trust call centre toll-free number.
- Sending their details on WhatsApp.
- Using the website "check your details", and click on the link https://www.tshiamisotrust.com/information/ status-check/ and use your industry number or RSA ID.
- Or visiting any TEBA office.

#### HOW TO LODGE A CLAIM WITH TSHIAMISO TRUST?

Once your eligibility to lodge a claim is established, the call centre will schedule an appointment for you to lodge. You will be informed about the documents required for the lodgement. It is important to note that you cannot send someone else to lodge on your behalf; you must appear in person at TEBA.

Tshiamo Trust currently has lodgement offices in South Africa, Lesotho, Eswatini, Botswana, and Mozambique, facilitated by our service provider, TEBA. There are currently no lodgement sites in Namibia, Zimbabwe and Malawi.

#### **DOCUMENTATION NEEDED TO LODGE A CLAIM**

- ID or Passport.
- Evidence of Industry number.
- Any available Records of Service.
- Any medical records ONLY related to silicosis or work-related TB (deceased claims).
- Approved ODMWA certificate if available (the Lodgement Officer will explain your options).
- Death certificate with the primary cause of death being silicosis or tuberculosis applicable to dependent claims.
- Proof of relationship to the deceased applicable to dependent claims.
- Letter of Executorship or Letter of Authority if the mineworker died on or after 10 December 2019.

#### WHAT HAPPENS AFTER MY APPOINTMENT?

- Tshiamo Trust will book you for a BME if necessary and will let you know which BME site you would need to present yourself in person. For claimants who have worked at qualifying mines for less than five years, the BME fee will be for the claimant's account. Should the claimant be found to be medically eligible, this fee will be reimbursed.
- All your medical documents will be reviewed by the Trust Medical Certification Panel. This is where a certificate of medical findings will be issued, your claim will be certified as either eligible or ineligible.
- If you are certified medically eligible by the Medical Certification Panel, all your documents will be reviewed by the Trust Certification Committee. They will certify the claim according to the criteria provided in the Trust Deed.
- If the Trust Certification Committee certifies the claim as eligible, the agent who represents the founding companies will review and confirm whether the record of service information provided is complete and motivated for Benefit Modifiers.
- Only if all your documents have been reviewed and approved, will Tshiamo Trust validate your banking
- information and make a payment into your bank account. Claimants should note that Tshiamo Trust can only make payments into the claimant's bank account.

# Rand Mutual Assurance

### **Rand Mutual Assurance**

For over 120 years, Rand Mutual Assurance (RMA) has been handling the administration of claims for occupational injuries and diseases according to COIDA.

#### Legislative Authority:

COIDA provides compensation for disablement caused by occupational injuries or diseases sustained or contracted by employees in the course of their employment, or for death resulting from such injuries or diseases. RMA has a license to administer COIDA in the mining, metal and steel industries issued by the Department of Employment and Labour.

#### WHO IS ELIGIBLE TO LODGE A CLAIM?

Any worker who sustains a work-related accident or occupational disease while working in the mining sector. RMA covers occupational injuries and diseases that are not covered by ODMWA, for example, noise-induced hearing loss and hand-arm vibration syndrome.

Any injury or disease should be reported by the employee or any other person on behalf of the employee to the employer. The employer needs to report to the injury or disease to RMA within the prescribed timeline for liability assessment and acceptance.

### STEPS TO FOLLOW TO REOPEN A CASE AFTER YOU HAVE LEFT THE INDUSTRY:



Consult a relevant specialist to determine if the deterioration or worsening of the condition is related to the reported injury or disease. This will be at your own cost.



The specialist will then submit a medical report with an assessment and a detailed treatment plan for clinical evaluation to RMA.



If RMA accepts liability, the payee will be reimbursed for the incurred costs.

#### SUMMARY OF CLAIMS PROCESS:

- 1. Complete the claim form.
- 2. Get the employer to sign the claim form.
- 3. Prepare and ensure you have all required supporting documents.
- 4. Submit the signed claim form with all supporting documents to your HR Office.
- 5. Alternatively, members and beneficiaries can visit any of MWPF walk-in centres or TEBA offices .

#### SUMMARY OF CLAIMS PROCESS OF AN UNCLAIMED BENEFIT:

- A claim that has not been claimed for 24 months is considered an unclaimed benefit.
- No documents will be accepted via email in-person verification will be done.
- Dependents of the deceased will need to produce a letter from the deceased family to nominate a recipient of the fund.
- Dependents need to produce their IDs along with a nomination letter from the family.
- An extensive investigation will then take place and, the funds will be distributed fairly.
- Beneficiaries can visit any of the MWPF walk-in centres, TEBA offices, or any of the MWPF offices near their mine (provided that your mine is still in operation).

#### **DOCUMENTS REQUIRED**

- A certified copy of your ID, birth certificate, or passport displaying your photo and the passport expiry date.
- Banking details (copy of bank statement stamped by the bank).
- Retirement claim form signed by the member and two employer authorised signatories. The withdrawal form must be stamped by the mine.

- An original or copy of an annuity letter, reflecting the annuity policy number (if you wish to transfer the full or part of your benefit to an annuity fund/registered pension/provident fund), or the original signed annuity application form, or the original letter from the broker (if applicable).
- A foreign exchange questionnaire (if applicable).
- A payslip (if your current income is less than R60 000 per year).
- A letter from your employer confirming your retirement.

- If you worked in a mining environment and were exposed to coal dust, and have been diagnosed with an OLD, you may be eligible to claim compensation from the MBOD/CCOD.
- You are also eligible for a BME every two years from the date of your initial claim submission to the MBOD.
- Ex-mineworkers should check if they have unclaimed benefits from pension funds such as the MWPF or Sentinel Fund.
- In the event of the death of an ex-mineworker, the family should contact the ex-employer or MBOD to arrange a post-mortem to remove the heart and lungs. These are sent to the NIOH for diagnosis and possible compensation submission to MBOD. Family consent is required for this process.
- Your health is our responsibility—whether you are a current or ex-mineworker. Please reach out to us if you need any assistance with healthcare or benefit claims.

If you are a Seriti ex-mineworker who contracted an OLD such as Pulmonary tuberculosis (TB), lung cancer, coal worker's pneumoconiosis and, chronic obstructive pulmonary disease **(please see definitions on page 11)** because of working in a dust exposing environment, you may potentially be eligible to claim for compensation from the MBOD/CCOD.

Seriti's medical surveillance program encourages ex-mineworkers to comply with the BME process for monitoring the development and the progression of OLD. Seriti will continuously explore effective and efficient processes to track ex-mineworkers with whom it has lost contact.

#### WHICH BENEFITS AM I ELIGIBLE TO CLAIM FOR?

- If you were exposed to coal dust while on duty and have been diagnosed with an OLD, you may be eligible to claim compensation from the MBOD/CCOD.
- In deceased ex-mineworkers cases, the NIOH can assist with the examination of cardio-respiratory organs (heart and lungs) to detect if an OLD was present. The NIOH will submit its findings to the MBOD/CCOD for potential compensation. This can only be done if consent has been given by the relevant beneficiaries of the deceased.

They also collaborate with Tshiamiso Trust, TEBA, and other stakeholders to track down ex-mineworkers who have unclaimed benefits. The company submits claims on behalf of employees and stays in contact with them or their families throughout the process.
- There is a home-based care program that is offered to eligible ex-employees with OLD that is coordinated and managed through the mine operation's Case Management team.
- Sibanye-Stillwater Health and Wellbeing has developed a program for ex-employees in cross border countries, partnering with service providers to monitor, manage and support eligible patients and ensure continuation of care.

#### WHICH BENEFITS AM I ALLOWED TO CLAIM FOR?

- If you performed work that exposed you to dust at a gold mine and have been diagnosed with an OLD, you may be eligible to claim from the Tshiamiso Trust and MBOD/CCOD.
- If you performed work that exposes you to dust at a coal mine and have been diagnosed with an OLD, you may be eligible to claim from the MBOD/CCOD.
- In the case of deceased mineworkers, the NIOH will assist with the post-mortem examination of cardiorespiratory organs (heart and lungs) to detect if an OLD was present. They will submit cases to the MBOD/ CCOD for possible compensation. A signed consent form from the family is needed for this process.
- Ex-mineworkers are also eligible for a 2-year BME at a DoH establishment nearest to their home or at One-stop Health Centre.






