- 1. Declaring that upon a proper interpretation of the *Mineral and Petroleum Resources Development Act, 2002* (MPRDA) once the Minister of Mineral Resources or his delegate has been satisfied:
- 1.1. in terms of section 23(1)(h) or item 7(2)(k) in Schedule II of the MPRDA that the grant of the mining right applied for or the conversion of the old order mining right will further the objects referred to in sections 2(d) and (f), in accordance with the charter developed in terms of section 100(2) of the MPRDA and applicable at the time, and grants such right or conversion, the Minister is not authorised to require the holder of the resultant right to take, and the holder of such right is not legally obliged to take, steps to further such objects outside of the terms of the

holder's mining right or approved social and labour plan or to comply with the provisions of newly revised charters from time to time;

- 1.2. in terms of sections 17(1)(f) or 17(4) of the MPRDA that the grant of the prospecting right applied for will further the object referred to in section 2(d) and grants such right, the Minister is not authorised to require the holder of the resultant right (or of any prospecting right converted in terms of Item 6 in Schedule II of the MPRDA) to take, and the holder of such right is not legally obliged to take, steps to further such object outside of the terms of the holder's prospecting right or to comply with the provisions of newly revised charters from time to time.
- 2. Reviewing the Reviewed Broad-based Black Economic Empowerment Charter for the South African Mining and Minerals Industry, 2016 published in Government Gazette No. 40923 of 15 June 2017 ("the 2017 Charter") in terms of sections 6(2)(i), 6(2)(a)(i) and (f)(i), 6(2)(e)(iii), 6(2)(e)(i), 6(2)(f)(ii)(aa), (bb) and (cc) and 6(2)(h) of the Promotion of Administrative Justice Act 3 of 2000 alternatively sections 1(c), 9, 25, 33, 77(3) and 213(1) of the Constitution of the Republic of South Africa, 1996.
- 3. Setting the 2017 Charter aside.
- 4. Directing the respondent to pay the costs of this application, such costs to include the costs of three counsel.
- 5. Further and/or alternative relief.
